Sub: Guideline and Timeline in respect of Merit-cum Means based Scholarship for the year 2017-18.

Dear Sir/Madam,

As you are aware under Merit-cum Means (MCM) based scholarship scheme, scholarships are awarded to meritorious student domiciled in West Bengal from amongst notified minorities communities viz. Muslims, Christians, Sikhs, Buddhists, Zoroastrians (Parsis) and Jains, pursuing professional and technical courses, at under-graduate and post-graduate levels in Institutions recognized by the appropriate authority, who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parents/guardian, from all sources does not exceed Rs.2.5 lakh.

2. From 2017-18, the online application of the Merit-cum Means (MCM) based scholarship scheme will be done through the common National Scholarship Web Portal (NSP 2.0) of the Government of India, under URL [www.scholarships.gov.in](http://www.scholarships.gov.in). Furthermore application procedure has been made available in [www.wbmdfc.org](http://www.wbmdfc.org). Only Online applications under the Scheme will be accepted and no request for offline applications will be entertained.

3. For Direct Benefit Transfer (DBT), the bank accounts of the scholarship holders Will also have to be seeded with Aadhaar number.

4. The Institute administration is accordingly requested to ensure wide publicity of the guideline and timeline for the year 2017-18.
