3. Validity of Quotation
 - a. Quotation shall remain valid for a period not less than **60 days** after the deadline date specified for submission.

 - i. which are properly signed and

 - c. The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.
6. Delivery shall be made at **Department of Earth and Environmental Studies, NIT, Durgapur.**
7. Payment shall be made immediately within 30 days after satisfactory installation, commissioning and acceptance of the Item.
8. Comprehensive onsite warranty shall be applicable to the supplied Items (wherever applicable) for a period of minimum 12 months from the date of installation.
